1. Introduction

OCTOPUS BOT ("Company," "we," "us," or "our") respects your privacy and is committed to protecting your personal data. - Wallet Information: Wallet addresses, keys, and transaction history.

5.2 Aggregated Data

We also collect Aggregated Data such as statistical or demographic data. It does not directly or indirectly reveal your identity.

5.3 Special Categories of Personal Data

We do not collect any special categories of personal data (e.g., race, religion, orientation, health, biometric data).
